<p>EVERY ENTRY AT A RECOGNIZED SHOW SHALL CONSTITUTE AN AGREEMENT AND AFFIRMATION THAT THE PERSON MAKING IT, ALONG WITH THE OWNER, LESSEE, TRAINER, MANAGER, AGENT, COACH, DRIVER, RIDER, AND HORSE: (1) SHALL BE SUBJECT TO THE CONSTITUTION AND RULES OF THE NEW ENGLAND HORSEMEN'S ASSOCIATION (NEHC), THE NEW HAMPSHIRE HORSE AND TRAILS ASSOCIATION (NHH&TA) AND THE LOCAL RULES OF THE SHOW; (2) THAT EVERY HORSE, RIDER AND/OR DRIVER IS ELIGIBLE AS ENTERED; (3) THAT THE OWNER AND ANY OF HIS/HER REPRESENTATIVES ARE BOUND BY THE CONSTITUTION AND RULES OF THE NEHC, THE NHH&TA AND THE SHOW AND WILL ACCEPT AS FINAL THE DECISION OF THE HEARING COMMITTEE ON ANY QUESTION ARISING UNDER SAID RULES AND AGREE TO HOLD THE SHOW, THE NEHC, THE NHH&TA, THEIR OFFICIALS, DIRECTORS AND EMPLOYEES HARMLESS FOR ANY ACTION TAKEN; (4) THAT THE OWNER, RIDER/DRIVER AND ANY OF THEIR AGENTS OR REPRESENTATIVES AGREE TO HOLD THE NEHC, THE NHH&TA, THE SHOW AND THEIR OFFICIALS, DIRECTORS, EMPLOYEES AND AGENTS HARMLESS FOR ANY INJURY OR LOSS SUFFERED DURING OR IN CONNECTION WITH THE SHOW, WHETHER OR NOT SUCH INJURY OR LOSS RESULTED, DIRECTLY OR INDIRECTLY, FROM THE NEGLIGENCE ACTS OR OMISSIONS OF SAID OFFICIALS, DIRECTORS, EMPLOYEES, OR AGENTS OF THE NEHC, THE NHH&TA OR SHOW. EVERY EXHIBITOR OR HIS/HER AGENT, AND TRAINER MUST SIGN AN ENTRY BLANK.
